- CERT Polska was established in 1996 (as CERT NASK)
- CERT Polska joined FIRST in 1997, TF-CSIRT in 2001, APWG in 2010
- Constituency: .pl → last resort CSIRT
- Other CERTs in Poland: PIONIER, TP, CERT.GOV.PL, Military CERT, Alior Bank CSIRT

- The attacks started on January 21st, after Polish government revealed plans to sign ACTA
- DDoS attacks with LOIC and HOIC
  - Sejm (Lower House of the Parliament)
  - Prime Minister
  - Internal Security Agency
  - CERT.GOV.PL
  - The Police
  - Central Anticorruption Bureau
  - Ministry of Foreign Affairs
  - Several private websites of politicians
  - and more...
- Coordinated via [irc.anonops.li](irc://irc.anonops.li), #poland
- Distinctive msg in requested URL („STOP ACTA”, „We Are Anonymous”), manipulations with User Agent and Referer
